The management of the website evaluates offers as per requirements and market demand. Against the contribution, royalties will be paid as monetary benefit along with acknowledgement on the website. Our declarations are as below:

1. Digital files should be shared through cloud for evaluation. Once it is selected, the intimation will be responded via email. Once the asset is received by the website team in technically accepted file format, confirmation will be received by the contributor along with a request for account details where the royalty will be remitted immediately to the account given by the contributor. The name of the contributor will be mentioned on the respective product page of the website with a link to the creator's work portfolio.

2. The selection will depend on different aspects, viz. creative excellence, sale probability, market demand, meaningful theme, etc. However, if no communication is received by the contributor within 15 days of the contribution, it may be treated as rejected. The right to accept or reject any creative asset is entirely reserved by the management of the website. No further queries would be entertained and the event of rejection cannot be challenged on any platform.

3. By offering the work, the contributor issues the right to use the creative intelligent property for reporduction by printing and selling of the product, directly or as a part of artwork. Photos of the final product will appear on the website only as an item on sale and no further communication will be made for any consent whatsoever from the contributor, once the royalty is paid.

4. As a standard practice, the email id of the contributor will be added to the mailing database of the website. However, if the contributor does not wish to receive communications further, there will be an option to stop.

5. The value of royalties for different items will be declared by the company in time to time. The intimation will be forwarded to existing contributors via email and will be published over the social media channels of the website.

6. The management of the website reserves the right to change these terms or withdraw this scheme at any point of time without any prior notice whatsoever.

Terms & Conditions

By participating in the competitive online events organised by orderprint.in, I agree with the following

1. The contributors extend an official right to the management of orderprint in to use their creative work in the form of art for commercial printing. This means the work of art will be reproduced as printed copies as a part of different printed items produced, marketed, and sold by the website through their channels. The contributors agree with the fact that his/her creative work can be combined with additional artworks and designs as per commercial requirements and they agree to allow those associations as and when required by the company without any prior notice.

2. The printing media, raw material, colours, print methods, finishing process, selling strategy and everything else related to commercial selling materials would be decided solely by the management of orderprint.in website. The contributors agree to refrain from any advice, suggestion, communication to the management of orderprint.in, unless requested officially for that.

3. The company holds the sole discretionary right to decide on the monetary value of royalty, percentage of royalty and selection of winner entries. No argument in any form or through any channel will be entertained and will not be maintainable in the court of law. The management reserves the right to cancel the entry at any point of time, for any conduct found harmful to the reputation of the business.

4. The management of the website support freedom of expression. But the laws, rules and penal provisions of the country should be strictly adhered to. The owner of the website will not be responsible if the contents of creative art attract any penal or legal action. In such instances, the entire responsibility is borne by the contributor, and proceedings against the website will not be maintainable in a court of law. The organiser reserves a complete right to reject any entry at any point of time without showing any reason whatsoever.

5. The entries should be unique art, as per the theme declared by the owner of the website. If it is found to be a work of plagiarism, the management reserve the right to reject it without showing any reason.

6. The terms and conditions stated above are subject to change with time as a policy of continued development of the website and its owner. The contributor of creative assets is bound by the terms and conditions published on the day of submission of the assets.

7. All disputes are subject to the jurisdiction of the courts of Kolkata, India only.
